Specific duties include:

• Identify impact funds who may be initiating or involved in a capital raising process for their current fund

- Develop and executive strategies to connect with and develop relationships with managers at the identified funds
- Review and analyze materials from prospective impact funds to determine alignment with Big Path and viability of a raise
- Assist with onboarding new fund clients to Big Path Capital's internal processes, provide on-going support and project management throughout the engagement
- Assist in reviewing, editing, and producing key outreach materials for clients
- Conduct research to identify limited partners with interest in impact funds to expand Big Path's network
- Evaluate limited partners within Big Path's network for alignment with engaged clients
- Execute outreach and follow-up strategies to impact investors in support for our fund clients
